All subscribers to the print edition of *The American Journal of Psychiatry* are automatically eligible to view the *Journal* online. The online version of the *Journal* allows you to conduct searches for topics of interest in issues going all the way back to 1844. Plus the only way readers can participate in the *Journal's* new CME Course program is to have an activated online subscription (note: there is an additional annual fee to be enrolled and eligible to receive up to 36 hours of category 1 CME credit).

Cover

In this issue Gibbons and colleagues (p. 1898) report the findings of their nationwide epidemiologic study exploring the relationship between antidepressant prescription rates and early adolescent suicide. They found that a lower suicide rate among children 5-14 years old was associated with a higher number of prescriptions for SSRI antidepressants. The map depicts annual suicide rates by U.S. county, with those counties in blue reporting rates below the national average and those in red reporting above average rates. The highest rates were typically found in some of the less densely populated areas of the western United States, many of which include areas with Indian reservations. However, the SSRI effect remained after allowance for average income of the general population and availability of psychiatrists, suggesting that lower suicide rates were not due to better access to health care.
