Cover

Do children reared by parents with psychiatric disorders have an increased risk for psychopathology themselves?

The question is posed by Wamboldt and Reiss (p.951) in their editorial discussing Weissman et al.'s 20-year follow up study (p.1001), which found that offspring of depressed parents were at higher risk for psychiatric and medical problems. A pedigree illustrative of the study is shown in the top left of the cover image.

Other studies in this issue examine the effects of early environmental factors on development. Teicher et al. (p.993) examined childhood maltreatment and found that verbal aggression and exposure to multiple forms of abuse are important psychiatric risk factors ("A. Teicher," the artist of the top right cover painting, was the first author's mother). Misri et al. (p.1026) found that prenatal exposure to psychotropic medications was not associated with impaired internalizing childhood behavior, but that altered maternal mood did have an identified impact.
