2006 Annual Report of the American Board of Psychiatry and Neurology, Inc.

The American Board of Psychiatry and Neurology (ABPN) is a nonprofit corporation founded in 1934. The mission of the ABPN is to serve the public interest by promoting excellence in the practice of psychiatry and neurology through certification and maintenance of certification processes.

The board consists of neurologists, who are nominated by the American Academy of Neurology and the American Neurological Association, and psychiatrists, who are nominated by the American College of Psychiatrists, the American Medical Association, and the American Psychiatric Association (APA).

The 2006 Executive Committee comprised Drs. Daniel K. Winstead, President; Harold P. Adams, Vice President; Michael V. Johnston, Secretary; Naleen N. Andrade, Treasurer; Patricia K. Coyle, Member-at-Large; and Larry R. Faulkner, Executive Vice President.

Strategic Planning Initiatives

The ABPN is in year 7 of its strategic plan, Vision 20/10: A Clearer View of the New Millennium. Major accomplishments to date include the following:

- Development and dissemination of updated core competencies for psychiatry and neurology.
- Development of core competencies for the subspecialties of addiction psychiatry, child and adolescent psychiatry, clinical neurophysiology, forensic psychiatry, geriatric psychiatry, neurodevelopmental disabilities, and vascular neurology.
- Migration of multiple-choice examinations to a computerized format and delivery of these examinations at Pearson VUE testing centers (first examination administered in March 2005).
- Revision of the part II oral examinations, including institution of a numerical grading system in April 2005, replacement of the audiovisual section of the psychia-

- try examination with a vignette section in May 2006, and development of new examiner orientation materials and procedures.
- Development of procedures for the evaluation of clinical skills during residency training. The credentialing procedures for neurologists and child neurologists who enter residency training (postgraduate year 2 for neurology, postgraduate year 3 for child neurology) on or after July 1, 2005, will include documentation of satisfactory performance in the evaluation of clinical skills. This will replace some aspects of the part II oral examination; other aspects will be tested on the computeradministered cognitive examination, beginning in 2008. Several meetings have been held with representatives from stakeholder organizations to discuss the assessment of clinical skills during psychiatric training.
- Initiation of test development activities in the recently approved subspecialties of neuromuscular medicine (with the American Board of Physical Medicine and Rehabilitation) and sleep medicine (with the American Board of Internal Medicine, the American Board of Pediatrics, and the American Board of Otolaryngology).
- Development of a Maintenance of Certification Program in congruence with the American Board of Medical Specialties (ABMS) requirements.
- Redesign and development of our web site (www. abpn.com), based on ongoing audits of audience requirements.

Maintenance of Certification

The Committee on Maintenance of Certification, chaired by Victor Reus, M.D., continued to develop the ABPN program for maintenance of certification. The group reviewed the ABMS guidelines for each of the four components of maintenance of certification (evidence of professional standing, evidence of self-assessment and lifelong learning, evidence of cognitive expertise, and evidence of performance in practice) and refined the requirements for fulfillment.

Leadership meetings were held with the American Academy of Neurology and APA to discuss the implementation of maintenance of certification. The board has complete responsibility for maintenance of certification, including all aspects of the cognitive (recertification) examinations.

The board reviewed a program for performance in practice that was under development at the University of Arkansas for possible implementation as a means to complete the requirements for performance in practice.

Core Competencies

The Core Competencies Committee, chaired by Michael Aminoff, M.D., D.Sc., continued to refine and update the outlines of core competencies for psychiatry and neurology. The latest versions are posted on the ABPN and American Academy of Neurology web sites.

Development of New Subspecialties

Sleep Medicine

In March 2005, the ABMS approved sleep medicine for psychiatrists and adult and child neurologists who are certified by the ABPN, as well as for diplomates of the American Board of Internal Medicine, the American Board of Pediatrics, and the American Board of Otolaryngology. The American Board of Internal Medicine is the administering board for the examination, and representatives from these boards serve on the test-writing committee. The first examination is scheduled for Nov. 15, 2007 (the application deadline was March 1, 2007).

Neuromuscular Medicine

In March 2005, the ABMS approved neuromuscular medicine for adult and child neurologists who are certified by the ABPN, as well as for diplomates of the American Board of Physical Medicine and Rehabilitation. The ABPN is the administering board for the examination. The first examination is scheduled for Sept. 8–12, 2008 (the application deadline is Feb. 1, 2008).

Hospice and Palliative Medicine

In September 2006, the ABMS approved hospice and palliative medicine for psychiatrists and adult and child neurologists who are certified by the ABPN, as well as for diplomates of the American Boards of Anesthesiology, Emergency Medicine, Family Medicine, Internal Medicine, Obstetrics and Gynecology, Pediatrics, Physical Medicine and Rehabilitation, Radiology, and Surgery. The American Board of Internal Medicine is the administering board for the examination. The first examination is scheduled for 2008.

The American Board of Radiology utilized the ABPN computer test center for examinations in January, July, and August 2006.

2006 Presentations and Publications

In 2006, ABPN directors and staff made presentations at many annual meetings and other gatherings (1–20). They also produced several publications (21–24).

2006 Communications

Volume 5 of the *ABPN Diplomate* newsletter, designed to provide information about maintenance of certification as it is developed, was issued as the *eDiplomate*, a PDF file online at our web site, in December 2006.

The *ABPN Update* was mailed out in March 2006 to approximately 4,300 ABPN directors, emeritus directors, committee members, examiners, training program directors, societies, and journals; it included information on two new directors, developments in the Maintenance of Certification Program, changes to examination format, subspecialty developments, examination schedules, and other news about the business of the board.

The ABPN designed and developed a new web site that allows access to information about the board and its activities. The new web site greatly enhances our communica-
