

- The American Journal of Psychiatry has an impact factor of 12.759, a rise from last year's 12.522 and 2-point rise from the previous year's 10.545, according to the recently released 2010 Journal Citation Reports® (Thomson Reuters, 2011), placing it 2nd among the 126 journals in psychiatry journals indexed, while still remaining the far-and-away leader in total citations.
- The American Journal of Psychiatry (AJP) is also the #2 journal in psychiatry in terms of immediacy according to Thomson Scientific's Immediacy Index. This important performance metric

is calculated by dividing the number of citations to articles published in a given year by the number of articles published in that year.

- The Immediacy Index is a good measure of how quickly a given journal's articles are cited—AJP's #2 placement is a result of publishing articles that are relevant, covering current "hot" topics and cutting-edge research, and getting these findings to the field faster with AJP in Advance, the Journal's online-ahead-of-print publication protocol.
- A recent poll conducted by the BioMedical & Life Sciences Division of The Special Libraries Associaton identified the 100 most influential journals in all of Biology & Medicine over the last 100 years. The American Journal of Psychiatry was among those honored, the only psychiatry/ psychology journal represented.

No other psychiatric journal reaches more psychiatrists with greater impact or immediacy than the journal that the overwhelming majority of psychiatrists considers essential: AJP.



'I just don't want to wake up every morning. You can't possibly know how I feel!' These words resonated against every surface in my small, stuffy and somewhat dated consultation room. What could I say to this woman sitting with her head buried in her hands in front of me? She was right after all: I couldn't possibly know how she felt. As a foundation year doctor with only a morsel of undergraduate psychiatry training behind me, here I was in my general practice rotation, faced with a patient with depression and the responsibility to treat them.



Later that evening my thoughts lingered on my encounter with this patient. I started doodling how she appeared to me, engulfed in her feelings of loneliness, worthlessness and guilt and unable to see a way out. This is my depiction of her as an outsider looking in, trying desperately to help.
