



Effects of Bundling Medication for Opioid Use Disorder With an mHealth Intervention Targeting Addiction: A Randomized Clinical Trial

As the opioid epidemic and its devastating consequences continue to worsen, the need for effective interventions grows increasingly urgent. This study tested whether a smartphone app designed to help with addiction recovery could improve rates of abstinence for patients in treatment that includes medications for opioid use disorder. The authors found that the app may help certain patients—in particular, those not experiencing withdrawal symptoms and those taking methadone—and that it may improve treatment utilization.




