In ammatory Biomarker Predicts Differential Outcome of Depression Treatment

Considerable research links inflammation to the diagnosis of major depressive disorder. However, it has remained unclear how this relationship might impact the care of specific patients with depression. Uher and colleagues show that patients with relatively high levels of C-reactive protein, an inflammatory marker, are particularly likely to response to nortriptyline, whereas patients with low levels of the marker are particularly likely to respond to citalopram. Thus, information on inflammation may help clinicians tailor treatment.

Combined Epigenetic and Genetic Biomarker Predicting Suicidal Behaviors

Considerable research suggests that suicide involves effects of genes, the environment, and their interaction. However, it remains unclear how such factors interact to shape brain function. The authors apply genome-wise methylation techniques to post-mortem data among individuals with a history of suicide, major depression, or neither factor. Across three independent data sets of post-mortem brains, they found signs of increased methylation in one particular gene, SKA2, and they extended this finding to peripheral blood samples from other cohorts of prospectively followed individuals. The consistency and strength of the findings call attention to a novel gene and the way that this gene influenced the response to stress.

The Demonstration (late 1950s/early 60s, poster paint on paper). Mary Bishop (b: currently unknown; d: 1990).

Mary Bishop's father had died in the First World War. She became psychotic while serving in the Women's Auxiliary Air Force during the Second World War. She was admitted to Netherne Hospital around 1946 and discharged circa 1983. During these years, she painted thousands of pictures in Edward Adamson's Netherne art depicting her isolation, studios depression, anger, and despair. About



300 works survive and are part of the recently found Adamson Collection. Adamson was a British artist who pioneered the use of art as therapy. In his book Art as Healing (1984; re-printed 2014, Adamson Collection Trust) he comments on The Demonstration: 'Here she illustrates exactly how it feels to be demonstrated in front of a group of medical students. She feels that she is entirely naked before an audience of blockheads' (p.21). Adamson adds: 'She told me that her existence was only made bearable by the fact that she could come and paint whenever she liked'.
